### Tournament Rules:

The following rules of this tournament will remain unchanged throughout the event. Interpretations of these rules shall be left exclusively to the Tournament Committee. The decision of the Tournament Director WILL BE FINAL.

- 1. Competition is based on five (5) bass per boat. Scoring will be based on the weight in pounds and ounces of bass (Largemouth, Kentucky or Spotted), with a minimum of twelve (12) inches, measured on an official flat board. Any fish under twelve (12) inches brought to the scale will be disqualified AND one (1) pound will be deducted from that person's weight as a penalty.
- 2. In case of a tie, the tie will be broken by the weight of the largest bass, then the length of the largest bass.
- 3. All bass must be caught on Rod and Reel, with artificial bait, AND must be caught on tournament day, between tournament hours.
- 4. No trolling with combustion engines of any type.
- 5. All entrants must check in and out with the Tournament Director. Scale will open at 1:30 PM with a weigh-in deadline of 2:00 PM.
- 6. Off-limit areas will be any areas under lock and key not accessible to the general public at all times.
- 7. All contestants must fish from the boat.
- 8. Life preservers must be worn at all times while the outboard is running.
- 9. Boats will stay 50 feet from another boat which is tied or anchored with the trolling motor out of the water.
- 10. Takeoff will be in Boat Number order. Boat Numbers will be assigned by registration order.

- 11. Any contestant who displays poor sportsmanship, violates any of the contest rules or violates any Louisiana fishing laws will be disqualified.
- 12. All boats must have an operating livewell capable of sustaining fish in a releasable condition, operating running lights, kill switch and proof of liability insurance.
- 13. There will be a <sup>1</sup>/<sub>4</sub> pound (0.25) penalty for any dead bass brought to the scale.
- 14. All bass, except for trophy bass, will be released immediately after weigh-in.
- 15. Any protest must be filed, in writing, within thirty (30) minutes of the completion of the weigh-in.
- 16. All entries are final.
- 17. No alcoholic beverages may be consumed during tournament hours.
- Any boat arriving at the launch site after the weighin deadline will be assessed a 1 pound penalty per minute. After 15 minutes, the boat will be disqualified.
- 19. All federal, state and local laws must be observed.
